QuickPay will be deduct the amount of your monthly payment from your bank account on the draft date you select. QuickPay does not give NCB access to any of your bank balances. The payment simply moves electronically from your bank to ours.

## How Will I Know When QuickPay is Activated?

It usually takes one payment cycle for QuickPay to be activated.
